**BRAINHUNTER ANNOUNCES MANAGEMENT AND DIRECTOR CHANGES  
Annual General Meeting Called for July 20, 2009**

**Toronto, Ontario**, June 12, 2009 – Brainhunter Inc. (“Brainhunter” or the “Company”) (TSX:BH) announces that John McKimm, Chairman & Chief Executive Officer and Director has resigned effective today. Mr. McKimm was a founder of Brainhunter and has directed the Company as Chairman & Chief Executive Officer since its origination in September, 2001. Under Mr. McKimm’s leadership, the Company reached an annual sales level in excess of \$200 Million, developed one of the leading Human Capital Management Technology platforms in the staffing industry and became one of the largest suppliers of professional staffing services and solutions in Canada. Mr. McKimm will remain an advisor to the Company for a period of time to ensure a smooth transition of responsibilities. Mr. Raj Singh, the current President & Chief Operating Officer of Brainhunter will also assume the Chief Executive Officer role. The Board has established an Executive Committee of three directors; Lead Director John Gillies, John Jaakkola and Mel Steinke.

The Company thanks Mr. McKimm for his contributions to the Company and wishes him every success in his future endeavours. Mr. McKimm remains a significant shareholder of Brainhunter.

The Company also announces that the Annual General Meeting of the Shareholders will be held on July 20, 2009, with further details to be announced subsequently. Over the past short while, there has been a dispute between two shareholders groups regarding the timing of the annual shareholders’ meeting. Pursuant to a court decision the record date was confirmed and the court determined that the shareholders’ meeting was to be held on or before July 21, 2009. The above management and director change was the result of negotiations between the groups to avoid a proxy fight.
